#### **Call to Order:**

The meeting was called to order by Jack Walker, President, via zoom at 7:00 PM. 48 households were represented.

## **Voting on Covenant Amendments:**

#### **Procedure**

Discussion regarding the minimum quorum needed. Ray Tomlinson explained that the quorum is reduced in the second meeting. Per By-Law Section 4, (b) Annual Meetings: "If a quorum is not present, an adjourned meeting may be called, and the required quorum at the adjourned meeting shall be one-half (1/2) of the quorum required at the preceding meeting." Mantie Pilzer issued a reminder that 90 votes are needed to pass amendments to the Covenants. Further discussion on the procedure to be followed during the meeting, once a quorum is reached, to address and vote on each amendment. Ray suggested that a motion should be made to open the meeting, followed by another motion to take up proposals in order. Votes were recorded in the Zoom Chat feature.

### Item 1: Superlien Amendment

This amendment to the Covenants puts the GHHA in a better position with banks in foreclosure situations. Important to get the assessments owed to the neighborhood, and adding this language to the Covenants will assist in this effort.
